## Articles of Incorporation Of California Miracles Center

### I

The name of this corporation is **California Miracles Center**

### II

- A. This corporation is a nonprofit religious corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law exclusively for religious purposes.
- B. The specific purpose of this corporation is to operate a church for religious purposes, to have regular religious meetings and to teach spiritual principles.

### III

### IV

- A. This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code.

No substantial part of the activities of this corporation shall consist of the carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

On the dissolution or winding up of the corporation, its assets remaining after payment of or provision for payment of all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for religious or charitable purposes and which has established its tax-exempt status under Section 501 (c)(3) of the Internal Revenue Law.
